2. The **State Department for Housing, Urban Development & Public Works** through the **Directorate of Urban and Metropolitan Development** now invites sealed Bids from eligible Bidders for:

3. Bidding will be conducted through National Competitive Procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers the

Guidelines for Procurement under IBRD Loans and IDA Credits, dated May 2004, revised October 2006 May 2010 and October 2017 (“Procurement Regulations”), and is open to all eligible Bidders as defined in the Procurement Regulations and below.

4. Interested eligible Bidders may obtain further information from the Principal Secretary, **State Department for Housing, Urban Development & Public Works, Cianda House, Koinange Street, 5th Floor, Room 515, P.O. Box 34477 – 00100, Nairobi, Kenya** and **inspect the bidding documents during office hours 09:00 to 17:00 hours during working days (Monday to Friday)** at the address given below.
5. Only the experienced Contractors who are registered with NCA Category 1, 2 or 3 for Security, CCTV & Access Control, Telecommunications, Structured Cabling Installations All with current registration Licences.
6. In addition, the contractors must be registered with **Communication Authority of Kenya (CAK)** with Current **Telecommunication Contractor License**.
7. There will be a mandatory pretender site visit on **Wednesday 11th July 2018**. Interested bidders are requested to assemble at **Ruiru Railway Station at 10:00 a.m.**
8. The Bidding documents in **English** may be purchased by interested eligible bidders upon the submission of a written application to the Principal Secretary, State Department for Housing and Urban Development, **Cianda House, Koinange Street, 5th Floor, Room 515** and upon payment of a non-refundable fee of **Ksh.1,000.00 per set** (or equivalent in a convertible currency). The method of payment will be cash or banker’s cheque from a reputable bank in Kenya
9. Bids must be delivered to the address below on or before **12:00 hours** East Africa time on **Friday, 27th July 2018** to the **Tender Box located at 10th Floor, Cianda House, Koinange Street, Nairobi, Kenya**. Electronic bidding **will not be** permitted. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders’ designated representatives and anyone who choose to attend at the address below at **12:05 hours** East Africa time on **Friday, 27th July 2018**.
10. All Bids must be accompanied by a **Bank Bid Security** as follows:
 - **Lot I – Kenya Shillings, Three Million, Seven Hundred Thousand Only (Ksh. 3.7 Million)**
 - **Lot II – Kenya Shillings, Two Million, Three Hundred Thousand Only (Ksh. 2.3 Million)**

For both Lots, the required bid security will be **the sum of the bid securities of the two Lots**, or equivalent amount in freely convertible currency
